The meeting was closed to stockholders due to health concerns due to COVID-19.

It was announced that the work order report for June 2020 has been posted.

Minutes of the regular meeting of June 15, 2020 and June 15, 2020 executive session had previously been distributed to all board members. Frank Moss moved to approve the minutes as submitted. Seconded by Charles Sawyer. Carried unanimously.

Treasurer Olsen reported that he has reviewed the financial statement for the month of June, 2020 and found it to be in good order. Charles Sawyer moved to approve the financial report. Seconded by Ray Olsen. Carried unanimously.

3. What is the name of the company used to deposit cash onto a prepaid or bank debit card?

The loan documents have been submitted to the Bank of Labor for the PPP loan. The government portal for banks to submit documents will not be available until August 7, 2020 Congress is discussing issuing another round of PPP loans because there is \$130 billion that has not been used. Manager will know more in the fall about whether the corporation can pursue another loan.

New Business to be Discussed:

The board reviewed the current rule regarding pools in the community. Charles Sawyer moved to change the language of the rule to read "Due to liability concerns, stockholders will not be allowed to have swimming pools unless they can be emptied every 24 hours and stored when not in use. No pools more than 2' high. No pools that require a filtration system." Seconded by Ray Olsen. Carried unanimously. Manager reported there are no pools in the community that she is aware of that will violate this rule.

The board discussed making a rule on trampolines which can also be a liability concern. Ray Olsen moved to create a rule that states "Trampolines are allowed only if they are insured and if The Homes, Inc. is named as an insured and current proof of insurance is provided to the office." Seconded by Charles Sawyer. Carried unanimously.

The board discussed the amount of directors' fees. Charles Sawyer moved to increase the directors' fees from ed unanimously.

## Mask Order Amended Further in Wyandotte County

A new Local Health Officer (LHO) Order was issued with additional amendments to the mask wearing requirements for Wyandotte County. The Order is set to go into effect at 12:01 AM on Wednesday, July 15.

The new amendments are:

- Athletes who are engaged in indoor activities and those exercising indoors are hereby required to wear masks or face coverings. This includes both team sports activities and in gym/weightlifting settings.
- Solitary outdoor exercise remains exempt from the face covering requirement.
- All children over 5 years of age and all staff in daycare/childcare/educational settings are required to wear masks or face coverings at all times unless actively eating, drinking, or sleeping. Medical exemptions from LHO 7/6/20 remain in effect.

"We've gotten many questions about the mask order, especially as it relates to exercise and sports. Socially distanced outdoor exercise is relatively safe, but we are really concerned about the potential for spread of the virus that causes COVID-19 with indoor exercise, whether it is people working out at a gym or participating in team sports," said Dr. Erin Corriveau, Deputy Medical Officer with the Unified Government Public Health Department (UGPHD). "Wearing a mask while exercising indoors may be a bit uncomfortable, and it takes some getting used to, but there's no scientific evidence to indicate that it is harmful to wear a mask during exercise."

"Another concern was about childcare settings. We feel it is incredibly important for face coverings to be worn in these settings for the protection of the children, staff, and their families," said Dr. Allen Greiner, Chief Medical Officer with the UGPHD. "We realize this is an adjustment for families and childcare providers, but it's the best way to minimize the risk of the coronavirus spreading in settings like this."

Masks are required locally for children over age five, but the CDC actually recommends masks for anyone age two or older. Children under age two should never wear masks as it is a safety hazard at that age.

These new amendments follow an LHO Order that was issued on July 6 adopting Governor Kelly's Executive Order 20-52 requiring masks for the state, with one amendment for Wyandotte County. This previous amendment remains in effect:

• The term "Public Space" includes public and private offices where more than one individual is congregating, workspaces where more than one individual is present, and any area of the office complex where more than one individual is present, such as a kitchen or break room.

Certain exceptions to the mask requirement for health, safety, and accessibility remain in effect, such as:

- People age five years or under children age two years and under in particular should not wear a face covering because of the risk of suffocation
- People with a medical condition, mental health condition, or disability that prevents wearing a face covering
- People who are deaf or hard of hearing, or communicating with a person who is deaf or hard of hearing, where the ability to see the mouth is essential for communication

#### Phase 3 of Reopening Continues

Wyandotte County remains under Phase 3 of the Ad Astra reopening plan. We'd initially announced that our Phase 3 extension would go until at least today (at least two weeks from when the Local Health Officer Order was issued). This was not designated as an official end date, merely a minimum amount of time we would remain in this phase. The Order remains in effect as we continue to see high numbers of new positive cases. ## **Testing Hours Expanded**

As of Tuesday, July 7, the Unified Government Public Health Department (UGPHD) changed its COVID-19 testing hours to Monday – Friday, 9 AM - 3 PM. This adds an additional two hours of testing time each day compared to the previous 1-5 PM schedule. We have seen increased traffic at our testing facility recently, and we expanded our hours to accommodate this need. Our testing resources at the UGPHD are designated to serve Wyandotte County, and as such our testing site is open to people who live or work in WyCo and either have symptoms of COVID-19, or have been exposed to COVID-19.

When people arrive for testing, they will be asked for:

- Their name and contact information (phone number, address) so we can contact them with their test results
- Information on any symptoms they are having or COVID-19 exposures (such as through close contact with someone who tested positive)
- Something to show that they either live or work in Wyandotte County
- Examples of what people can bring to show residence or employment in WyCo:
- Utility bill, bank statement, or other piece of mail with their name and address
- Vehicle registration or insurance
- A pay stub
- A work badge
- A photo ID
- Other items clearly indicating that the person lives or works in Wyandotte County

We do not require people to provide a government issued ID, and we do not retain any copies of a person's proof of residence or employment in WyCo. We ask for this because our testing resources are still limited, and the funding and supplies for our site are earmarked to serve Wyandotte County. Please note, some clinical services provided by the UGPHD have been put on hold for the month of July in order to expand COVID-19 testing and support our efforts to address the pandemic. The majority of the UGPHD's other program areas remain in operation, with precautions put in place due to COVID-19. Wyandotte County residents can get clinical services like family planning, sexually transmitted infection (STI) services, immunizations, and laboratory services at several local safety net clinics. Please note, clinic hours or procedures at these locations may have changed in response to COVID-19.

## **Recycling & Yard Waste Center**

The Unified Government's Public Works Department is re-opening Wyandotte County's Recycling & Yard Waste Center on July 10.

Closed since late March 2020 due to the impact of COVID-19 in Wyandotte County, the Center will re-open to the public every other Friday and Saturday from 10 AM to 3 PM beginning July 10. Wyandotte County residents will need to show proof of residency, such as a BPU bill. The Center is not open to non-profits, businesses, or other commercial entities.

Due to revenue shortfalls caused by the sharp drop in sales and gasoline tax collections during Wyandotte County's Stay-At-Home response to COVID-19, the Recycling & Yard Waste Center will have limited hours.

During the 2020 season, the Recycling & Yard Waste Center will be open from 10 AM to 3 PM on the following days:

July 10, 11, 24, 25 August 7, 8, 21, 22 September 4, 5, 18, 19 October 2, 3, 16, 17, 30, 31 November 13, 14

Residents are required to wear masks or face coverings and practice social distancing while at the Center until otherwise directed by the Unified Government's Public Health Department.

### Who Can Use the Recycling & Yard Waste Center?

The Recycling & Yard Waste Center is available at no charge to all residents of Wyandotte County. Wyandotte County residents will need to show proof of residency, such as a BPU bill. The Recycling & Yard Waste Center is not open to non-profits, businesses, or other commercial entities.

## What Recycling is Accepted?

Clear, brown, and colored glass is accepted at the Center. The glass does not have to be separated by color and will be placed in the same container. In addition, other recyclables do not need to be separated and will be placed in one container. Other recyclable items accepted include newspapers, magazines, mixed office paper, cardboard, paperboard, food & beverage cans, and plastics. Please remove recyclables from plastic bags before placing them into recycling containers. Please break down cardboard boxes.

## What Recycling is Not Accepted?

No plastic bags. No plastic toys. No motor oil or other auto product containers. No herbicide or pesticide containers. No Styrofoam materials such as peanuts, packaging blocks/sheets, or cups. No plastic cereal box or cake box liner bags. No plastic 6-pack holders. No plastic pipe, PVC pipe. No plastic building materials or plastic sheet materials.

#### What Yard Waste is Accepted?

Wyandotte County residents can take grass clippings, garden trimmings, leaves, and branches to the Recycling & Yard Waste Drop Off Center.

#### What Yard Waste Is Not Accepted?

The Center cannot accept stumps and logs larger than 12 inches in diameter or items more than four feet in length

## Where Can I Take Items not Accepted at the Recycling & Yard Waste Center?

The Johnson County landfill will accept landscape waste delivered by Wyandotte County residents, free of charge, based on the following guidelines:

- Yard waste is defined as leaves, grass clippings, branches 3 inches or less in diameter and 4 feet or less in length, fallen fruit, nuts, and acorns.
- Yard waste must be generated from a residential property within Wyandotte County
- Yard waste must be transported to the landfill by the resident disposing of it
- Visitors must provide proof of residency upon arrival at the landfill
- Residents are limited to one-load of no more than 3-cubic yards of material per week
- Material not accepted as landscape/yard waste includes, but is not limited to, branches/stumps in excess of 3 inches in diameter, cut or rolls of sod, and manure

Material is accepted Monday through Friday from 8:00 AM to 3:30 PM, and on Saturdays from 8:00 AM to 12:00 PM at 17955 Holliday Drive, Shawnee, Kansas 66217.

## When is the Next Household Hazardous Waste Disposal Event?

The Household Hazardous Waste Center remains closed until further notice.

## **BPU Scam Alert**

We're experiencing an increase in customers alerting us of scam calls and imposters knocking on their doors demanding payment. Here are some of the scam calls customers have received this week: • Caller said he was sending someone out to turn off the power unless \$800 was paid by MoneyPak (MoneyPak is used to deposit cash onto a prepaid or bank debit card). The scammer gave instructions on how to get a MoneyPak before hanging up. • Caller stated the customer owed over \$200 and someone would be out to disconnect if the balance was not paid. • Two customers experienced a scam call followed by a knock on the door requesting money for a BPU bill. Your safety and well-being are our top concerns. Our staff will NEVER demand payment or threaten to disconnect services. Remember these tips: • Always ask to see BPU identification if anyone approaches you, or your door claiming to be a BPU employee. If they don't show you I.D., close the door and call the police. • If you get a call and you're unsure if the person works for BPU, ask for their name, hang up, and call us at (913) 573-9190.
