As of Friday, July 30th the Unified Government's Board of Commissioners highly recommends a six-week indoor mask mandate for both vaccinated and unvaccinated people. Kansas City, MO reinstated its indoor mask mandate for individuals who are at least 5 years old — regardless of COVID-19 vaccination status — for the month of August.

Now that mask mandates have been lifted everyone is safe....right! NO! Only half of the population of the United States has received the vaccine. Not all people you see in public not wearing a face mask have been vaccinated. Unvaccinated people are still vulnerable to the virus and its rising variants. If you have made the personal decision not to be vaccinated, please take the same precautions you did last year. Wear a mask in public, social distance at least 6' from others and wash your hands frequently. Over 600 businesses in the KC Metro area have closed due to Covid 19. No one wants the restraints from last year happening again. Keep yourself and others safe.

The regular monthly meeting of the Board of Directors of The Homes, Inc. was called to order at 5:30 p.m. on July 19, 2021.

Present were: Frank Moss, Ray Olsen, Jerry DeMeyer and Ronald Bond, Board Members; Elizabeth Bothwell, Manager; Greg Goheen, attorney; and Karen Brokesh, Transcriber. Charles Sawyer was absent.

The meeting was closed to stockholders due to health concerns due to COVID-19.

Frank Moss moved to appoint Ronald Bond, 15/17 Summitteest, to the board of director to fill the vacant position created by the resignation of Effie Barber. Seconded by Ray Olsen. Carried unanimously.

It was announced that the work order report for June 2021 has been posted.

Minutes of the regular meeting of June 21, 2021 and June 21, 2021, executive session had previously been distributed to all board members. Frank Moss moved to approve the minutes as submitted. Seconded by Ray Olsen. Carried unanimously.

Treasurer Olsen reported that he has reviewed the financial statement for the month of June, 2021 and found them to be in good order. Ray Olsen moved to approve the financial report. Seconded by Jerry DeMeyer. Carried unanimously.

There were no stockholder change requests approved by the manager.

The board reviewed the stockholder change request submitted by Cristian Navarro, 825 Roswell, to install an 11 x 16 deck. Work will be done by self.

The board reviewed the stockholder change request submitted by John Delameter, 16 Summitcrest, to remove bathtub and install a shower.

Jerry DeMeyer moved to approve the stockholder change requests. Seconded by Ray Olsen. Carried unanimously.

3. How many units are for sale?

A vehicle was purchased for the maintenance crew. The truck has 130,000 miles and was purchased for \$12,500. Maintenance is happy with it so far.

Gravel will not be able to be used to surface an extra parking area behind 129 Viewcrest. Asphalt would be the next cheapest material to use. A rough estimate of the cost for a 100 foot by 40 foot section of asphalt is \$12,000. Next week, manager is meeting with the BPU Electric, Fire Department, Building Inspection, Planning Department, Planning Engineering and BPU Water to move forward with the project. No known utilities are in the area. Manager is also going to request a smaller parking area to be installed between 753-759 and 771-777 Manorcrest.

New Business to be Discussed:

Jose Rodriguez has been hired as a new maintenance technician. He speaks Spanish which will be a huge addition to the team.

Fire extinguisher and smoke alarm inspections will begin in August.

There are 12 porch roofs that are scheduled for replacement. Manager looked into installing A frame roofs but the cost would be almost twice as much which are no feasible.

A request has been made for the City to trim back the bushes located at the entrance all the way to Roswell Park. Two trees are being removed across the street from the office which will also increase visibility for drivers.

The Wyandotte County Back to School Fair is an annual event where Wyandotte County students receive school supplies, backpacks, immunizations, health screenings and other community resources *at no cost*.

Details About This Year's Event

One of the key objectives of the Back to School Fair is to provide students with a variety of health-related screenings and services prior to going back to school.

At this year's Back to School Fair, students can get the following medical services on a first come, first-served basis:

- Sports physicals and school physicals, provided by the University of Kansas Medical Center Department of Family Medicine;
- COVID-19 vaccinations for students 12 and over provided by the Unified Government Public Health Department;
- School immunizations for students of all ages, also provided by the Unified Government Public Health Department;
- Vision screenings provided by the Lion's Club of Wyandotte County;
- Dental and vision screenings provided by Adventure Dental.

Items are available for free while supplies last on **Saturday**, **August 7 from 8AM until 1PM**:

- 2,400 backpacks filled with school supplies, courtesy of the Wyandotte County Back to School Fair Committee;
- New books donated by the Kansas City, Kansas Public Library system;
- Hygiene kits courtesy of the Kansas City, Kansas Community College;
- Dental kits provided by Adventure Dental.

The Wyandotte County Back to School Fair Planning Committee is composed of volunteers from various nonprofit and for-profit entities that work together to fundraise and coordinate the activities of the fair. COVID-19 Updates and Vaccine Incentives

As the number of new COVID cases continues to surge in Wyandotte County, the Unified Government Public Health Department (UGPHD) is getting creative in finding new ways to inspire residents to get their free COVID-19 vaccinations.

As of Monday, July 26, there are 107 confirmed cases of COVID-19 in Wyandotte County found to have been caused by the fast-spreading Delta variant. In fact, 100 percent of the COVID cases that have been sequenced since July 1st have been found to be caused by the Delta variant. Keep in mind that only a small percentage of all of the COVID-19 cases in the county are put through the sequencing process. So that means that overall, the vast majority of new COVID-19 cases in Wyandotte County are almost certainly due to the Delta variant.

Additionally, statistics show that the vast majority of new COVID-19 cases in Wyandotte County are occurring in unvaccinated people. The majority of Wyandotte County residents still have not received a COVID-19 vaccine, and vaccination rates in the County continue to lag behind other counties in the region. According to state and local public health experts, communities with low vaccination rates are at especially high risk with the presence of the Delta variant, because of how easily it spreads.

The Latest Vaccine Incentives

To encourage Wyandotte County residents to get their free COVID-19 vaccinations, the UGPHD is offering "Spin to Win" instant prizes at its vaccination facility at the former Kmart store at 7836 State Avenue.

Now people ages 12 and older who get vaccinated at the Kmart facility can "Spin to Win" one of a variety of instant prizes, or they can be entered into a raffle to win one of two, \$500 VISA gift cards given away each day. The "Spin to Win" and raffle prizes are available for Wyandotte County residents only. Minors must be accompanied by a parent or guardian in order to participate.

Instant "Spin to Win" prizes include:

- \$50 VISA gift card
- \$25 VISA gift card
- \$15 gift card to a local restaurant
- Custom T-shirt

Those who live in Wyandotte County who come into a UGPHD site for a COVID-19 test will receive a \$25 VISA gift card (one gift per person, **while supplies last**. People coming in to get vaccinated can also be tested and receive the incentives available for both vaccinations and testing. The UGPHD offers saliva tests (these don't require the nasal swab – it's a "spit test").

COVID-19 Guidance for the 2021-2022 School Year

The Unified Government Public Health Department has provided the following recommendations to our local school districts. Take a look and consider educating your students about these best practices:

- 1. **Universal and correct use of masks:** UGPHD recommends that masks should be required in all classroom and non-classroom settings, including hallways, restrooms, gyms, buses and offices. This recommendation is not only supported by the CDC and the UGPHD, but also by the American Academy of Physicians.
- 2. **Physical distancing:** The UGPHD recommends that schools try to distance students at least 3 feet' apart during normal classroom settings. During more "high-risk" activities such as singing, shouting, band or athletics, the UGPHD recommends at least 6 feet of distance be maintained.
- 3. **Diagnostic and screening testing:** The UGPHD recommends schools offer diagnostic testing for any students or staff exhibiting COVID symptoms, and it offers schools assistance with implementing testing if needed.
- 4. **Vaccinations (as applicable):** The UGPHD offered schools assistance with setting up mobile vaccination events if needed, for students and staff age 12 and older.
- 5. Contact tracing in combination with isolation and quarantine: The UGPHD recommended that students and staff who test positive for COVID remain home for 10 days after their symptoms begin, or 10 days from their positive test, if no symptoms are present. Unvaccinated close contacts of a positive patient (within 6 feet for 10 minutes or longer) should quarantine at home for 14 days from their last date of exposure.
- 6. **Handwashing and respiratory etiquette:** The basic principles of proper handwashing and covering coughs and sneezes should be emphasized among students and staff. Provide adequate supplies such as soap, hand sanitizer, tissues, and trash cans in classrooms.

Cleaning and maintaining healthy facilities: Make changes to physical spaces to maintain a healthy environment and facilities, including improving ventilation. Routinely clean high-touch surfaces, such as doorknobs and light switches.
