

MINUTES OF THE BOARD OF DIRECTORS THE HOMES, INC. January 13, 2020

The regular monthly meeting of the Board of Directors of The Homes, Inc. was called to order at 6:00 p.m. on January 13, 2020.

Present were: Effie Barber, Ray Olsen, Rebecca Westpfahl and Frank Moss, Board Members; Elizabeth

Bothwell, Manager; Greg Goheen, Attorney; and Karen Brokesh, Transcriber. Beatrice Arce was

absent.

Sixteen stockholders and residents attended the meeting.

The stockholders and occupants were welcomed to the meeting. All persons in attendance were asked to hold their questions and comments until after the finish of regular business at which time anyone who wishes to speak will be allowed to make a statement.

All attendees to state their name and address so that the minutes can accurately reflect all comments made during the open session. Everyone was asked to hold their comments until executive session or to speak with the manager one-on-one if they did not want their comments reflected in open session.

Stockholders are reminded that if they have a problem with their unit, to please report it to the office during regular business hours.

It was announced that the work order report for November and December 2019 has been posted.

Minutes of the regular meeting of November 18, 2019 and November 18, 2019 executive session had previously been distributed to all board members. Ray Olsen moved to approve the regular meeting minutes as submitted. Seconded by Effie Barber. Carried unanimously. Approval of the executive minutes was tabled pending further discussion in executive session.

Treasurer Olsen reported that he has reviewed the financial statement for the months of November and December, 2019 and found them to be in good order. Rebecca Westpfahl asked why she had not been provided with the financial documents she had requested. Manager responded that Ms. Westpfahl was not at home and manager did not want to leave the financial documents posted on her door. Ray Olsen moved to approve the financial report. Seconded by Frank Moss. Motion was opposed by Effie Barber and Rebecca Westpfahl. The matter was tabled.

There were no stockholder change requests for approval by the manager.

Manager is looking at alternatives to this requirement by the City. The City did not require the engineering and surveying work when additional parking was installed four years ago.

Two trucks have been purchased for the maintenance department.

Effie Barber moved to set the date of the annual meeting for Friday, March 6, 2020. Seconded by Ray Olsen. Carried unanimously.

Ray Olsen moved to mail nomination forms for the annual meeting on or before January 17, 2020. Seconded by Effie Barber. Carried unanimously.

Effie Barber moved that all nomination forms must be returned to the office no later than February 7, 2020. Seconded by Ray Olsen. Carried unanimously.

Effie Barber moved to send the notice of the annual meeting for February 2, 2020. Seconded by Ray Olsen. Carried unanimously.

Ray Olsen moved to appoint Joanne DeMeyer, Sherry McCool and Karin Miller as ballot inspectors. Seconded by Frank Moss. Carried unanimously.

BPU Warns Customers of Telephone Scams Targeting Customers

The Kansas City Board of Public Utilities (BPU) is warning customers about phone scams targeting electricity customers regarding their utility bills.

The latest scam involves telephone callers claiming to be from a utility company and then using various techniques to defraud customers. Some threaten customers with disconnecting electric service to their home or business if they do not make a payment immediately.

In some instances, the caller requests that the customer purchase a money gram or a prepaid credit card and the caller gives out a return number for customers to call back.

Some of the scammers are using software that fraudulently mimics a utility company's phone number that appears on the Caller ID.

"We've had numerous reports from customers who have been contacted by these methods. Any customers who receive such a call should refrain from providing any personal or banking information, hang up and should instead contact the BPU Customer Service Department," stated David Mehlhaff, BPU Chief Communications Officer.

BPU customer service representatives are reassuring customers that this is a scam and warning them to not give out any personal information to these scam artists. The BPU Customer Service Department can be reached by calling 913-573-9190.

Mehlhaff added some other important safety tips to keep in mind:

Never give credit card, debit card, Social Security, ATM, checking or savings account numbers to anyone who comes to your home, calls, texts and/or sends an email requesting this information in respect to your utility bill, without verifying that person is with BPU by either asking to see company identification or by calling BPU's Customer Service Department. Be suspicious if you receive an email regarding your utility bill if you have not requested online communications from BPU. For customers using BPU's online bill pay system, always make online payments directly through bpu.com. Never provide personal information via email or click on any suspicious links.

If you are 62 or older, you are exempt from late fees on your BPU bill. You must call the BPU service number and give them your date of birth.

Watch out for anyone coming to your door selling Google Smart thermostats or other Google products. It is a fraud. They will tell you that they are required to go into your home to confirm your system and they have the right. Close the door and call the police. They are wearing clothes with Google on it and have paperwork. Look legit but definitely not. They have threatened homeowners and tried to force their way into homes across the area. These guys were in South Windsor the afternoon of Dec 19. **Confirmed with Google that they**NEVER sell door to door Do NOT let them in and sign nothing. Call 911. Warn your friends and family especially seniors!

Utility Tax Rebate Program

General information for 2020

To qualify for the refund, all three must apply:

Be a Kansas City, Kansas resident. Residents of Bonner Springs and Edwardsville are not eligible for the refund. Be 65 years of age or older during the entire calendar year of 2019 (born prior to January 1, 1954). Gross income from all sources, including that of spouse, shall not exceed \$25,000 per year.

To apply for the refund: You must come to the Unified Government Clerk's office- City Hall, third floor, Room 323, (701 North 7th street, Kansas City, Kansas 66101). Bring all 2019 utility bills for telephone, gas, and BPU. You must also provide proof of income received in 2019 from social security, pensions, w-2s, interest earned, rental properties, etc. Said information may also be mailed to the clerk's office. All mailins must be postmarked no later than Tuesday, March 31, 2020.

Make application between January 2 and March 31, 2020, between the hours of 8:30 a.m. and 4:00 p.m. The area agency on aging, located at the midtown KCK Metrocenter (849 north 47th street) will fill out applications by appointment only on Tuesdays and Thursdays starting February 4, 2020. Make an appointment by calling 913-573-8531.

If you are eligible, your refund will be the total of the following (not to exceed \$150): Gas franchise tax paid to Kansas gas or Atmos energy 90% of water pollution control charges paid to the board of public utilities 11.9% of water and electricity paid to the board of public utilities Franchise tax (special municipal charge) paid to AT&T

Please note: individuals other than the senior citizen and spouse living in the residence will result in the refund being lowered by one-half for water pollution, electricity/water and gas. Example, adult children and those with children living with the applicant. This also includes adult grandchildren. City Sales Tax Refund

General information for 2020

To qualify for the refund, all three must apply:

Be a Kansas City, Kansas resident. Residents of Bonner Springs and Edwardsville are not eligible for the refund.

Be 65 years of age or older during the entire calendar year of 2019 (born prior to January 1, 1954). Gross income from all sources, including that of spouse, shall not exceed \$25,000 per year. To apply for the refund:

You must come to the Unified Government Clerk's office- City Hall, third floor, Room 323, (701 north 7th street, Kansas City, Kansas 66101). Provide proof of income received in 2019 from social security, pensions, W-2s, interest earned, rental properties, etc. Said information may also be mailed to the clerk's office. All mail-ins must be postmarked no later than Tuesday, March 31, 2020.

Make application between January 2 and March 31, 2020, between the hours of 8:30 a.m. and 4:00 p.m.

The area agency on aging, located at the midtown KCK Metrocenter (849 north 47th street) will fill out applications by appointment only on Tuesdays and Thursdays starting February 4, 2020. Make an appointment by calling 913-573-8531.

HELPFUL HINTS ABOUT LIVING IN THE HOMES

PLUMBING: DO NOT FLUSH FLUSHABLE WIPES. The pipes in our homes are over 70 years old. They do not have the capacity to wash away any other material. Do not flush baby wipes, feminine hygiene products, diapers, paper towels, Q tips, etc. The sink and tub drains are only for water disposal. Do not force items down the drains. If maintenance finds these items consistently causing a backup in your pipes you may be charged for the repair.

LITTERING. Think twice about throwing your trash out your car window or into someone's yard. First, it's rude and selfish. Someone will have to pick it up and most of the time it is the maintenance staff. This takes time and money away from other residents needs. Second, it is against the law. Littering is a Class C violation that is punishable by a fine up to a \$500.00. If you are witnessed littering the police will be called and you will be charged, by The Homes, for the time it takes to pick it up and dispose of it.

BE KIND! If it snows don't park in a spot you normally wouldn't. If a neighbor takes the time to shovel out the space they normally park at, then respect their hard work and don't park there.

AUTOMOBILE REPAIR. It is against the rules to work on your vehicle in The Homes. If your vehicle needs repair then you will have to go out of the neighborhood or take your vehicle to a mechanic. Unless you are changing a flat tire you should never put your vehicle on a jack in the Homes.

PARKING: The Homes does not have assigned parking. Please be considerate of your neighbors and their parking needs. Try not to park in a spot that is normally used by your neighbor. If you have guest, have them park in the overflow lots. **DO NOT PARK OVER THE LINES. NEVER PARK IN YARDS OR COMMON GROUND.**

NOISE. Please be mindful of the level of noise you create. It is our responsibility to keep the sound we make to a reasonable level so we are not disturbing our neighbors. Sometimes, simply communicating with your neighbors and working out an understanding can resolve this and many other problems.

YARDS & PORCHES: Please take the time to clean up/organize your yard and porch. The size of our porches do not allow for you to keep many items on them before they start to look cluttered and messy. If you do not have a shed an affordable idea to store your items in are deck and patio boxes. They range in cost from \$30 to \$100 and can be purchased on-line or at your local discount store. Items that should not be on your porch: appliances, boxes, buckets, mops, paint containers or any other "non outdoor" items. The office offers free paint for the porches.

KEEP FURNACE AND WATER HEATER AREAS CLEAN. Having too many clothes, boxes, or general clutter in your utility area can be a fire hazard. Please keep yourself and your neighbors safe and keep your utility areas clean. **DO NOT PILE CLOTHES OR OTHER ITEMS ON TOP OF THE WATER HEATER OR FLU AREA.**

SPEEDING. The speed limit in The Homes, Inc. is 20 mph. It only takes a few seconds for a distracted child to dart out in the road. Please be aware and safe while driving.

CURRENT CONTACT NUMBERS. It is crucial that the office can reach every resident. We might have a question about a work order or need to alert you to damage to your unit because of a fire. Please call the office and give us your current telephone number.

During the month of March you will receive a postcard from the US Govt. requesting census information.

It is VERY IMPORTANT that you furnish this information. The number of people in Wyandotte County will determine the amount of federal funds we receive. It doesn't ask for your name, social security number, citizenship status, etc. There are only 10 questions.

You can reply by phone (may be a long wait), by mail (you have to get a mail-in form) or online.

If you don't have a computer on the internet, you can go to the library and use their internet or come to the Anvers' home on Viewcrest and use their internet. Call first to make sure they are available at 913-342-2660.

After April 1st the Census will make personal visits until they get the information.

According to United States Code, Title 13 (Census), Chapter 7 (Offenses and Penalties), SubChapter II, if you're over 18 and refuse to answer all or part of the census, you can be fined up to \$100. If you give false answers, you're subject to a fine of up to \$500.
