1. When is the Credit Union Annual Meeting?

NEIGHBORHOOD WATCH LEADERSHIP NEEDED

Neighborhood Watch is one of the oldest and most effective crime prevention programs in the country, bringing citizens together with law enforcement to deter crime and make communities safer. Sponsored by the National Sheriffs' Association (NSA), Neighborhood Watch can trace its roots back to the days of colonial settlements, when night watchmen patrolled the streets. The modern version of Neighborhood Watch was developed in response to requests from sheriffs and police chiefs who were looking for a crime prevention program that would involve citizens and address an increasing number of burglaries. Launched in 1972, Neighborhood Watch counts on citizens to organize themselves and work with law enforcement to keep a trained eye and ear on their communities, while demonstrating their presence at all times of day and night. (The program took off quickly: in just ten years, NSA data showed that 12 percent of the population was involved in a Neighborhood Watch.) Neighborhood Watch works because it reduces opportunities for crime to occur; it doesn't rely on altering or changing the criminal's behavior or motivation.

Tips

- Work with the police or sheriff's office. These agencies are critical to a Watch group's credibility and are the source of necessary information and training.
- Link up with your victims' services office to get your members trained in helping victims of crime.
- Hold regular meetings to help residents get to know each other and to decide upon program strategies and activities.
- Consider linking with an existing organization, such as a citizens' association, community development office, tenants' association, or housing authority. They may be able to provide an existing infrastructure you can use.
- Canvass door-to-door to recruit members.
- Ask people who seldom leave their homes to be "window watchers," looking out for children and reporting any unusual activities in the neighborhood.
- Translate crime and drug prevention materials into Spanish or other languages needed by non-English speakers in your community. If necessary, have a translator at meetings.
- Sponsor a crime and drug prevention fair at a church hall, temple, shopping mall, or community center.
- Gather the facts about crime in your neighborhood. Check police reports, conduct victimization surveys, and learn residents' perceptions about crimes. Often, residents' opinions are not supported by facts, and accurate information can reduce the fear of crime.
- Physical conditions like abandoned cars or overgrown vacant lots contribute to crime. Sponsor cleanups, encourage residents to beautify the area, and ask them to turn on outdoor lights at night.
- Work with small businesses to repair rundown storefronts, clean up littered streets, and create jobs for young people.
- Start a block parent program to help children cope with emergencies while walking to and from school or playing in the area.
- Emphasize that Watch groups are not vigilantes and should not assume the role of the police. Their duty is to ask neighbors to be alert, observant, and caring—and to report suspicious activity or crimes immediately to the police.

February 21, 2022

The regular monthly meeting of the Board of Directors of The Homes, Inc. was called to order at 5:30 p.m. on February 21, 2022.

Two stockholders and residents attended the meeting via videoconference.

It was announced that the work order reports for December 2021 and January 2022 have been posted.

Minutes of the regular meeting of December 20, 2021 and December 20, 2021, executive session had previously been distributed to all board members. Frank Moss moved to approve the minutes as submitted. Seconded by Ron Bond. Carried unanimously.

Treasurer Olsen reported that he has reviewed the financial statements for the months of December, 2021 and January, 2022 and found them to be in good order. Ray Olsen moved to approve the financial report. Seconded by Ron Bond. Carried unanimously.

The stockholder change request approved by the manager was that of Cristian Navarro, 825 Roswell, to install an 8 x 10 shed.

There were no stockholder change requests for board approval.

After being informed that the stock transfers were in order, it was moved by Jerry Demeyer and seconded by Ray Olsen that the Corporation waive its option to purchase the shares of stock and approve transfer of same. Carried unanimously. The manager was reminded that all original signed stock certificates must be stored with the credit union if the stockholder has an outstanding loan.

Old Business to be Discussed:

The Unified Government subcommittee is still reviewing and evaluating the next steps with the American Rescue Plan Act funding. The program may be open for applications in April. Currently, The Homes would not qualify for employee incentives or infrastructure repairs but could qualify in the future. There is a possibility that residents could get rental assistance similar to KERA. The manager will continue to monitor the progress of this program.

A third round of letters were sent to stockholders about signing the petition adding parking to The Homes by the Unified Government. So far, the letter has 226 signatures. The goal is to get 300 signatures before it is submitted to the Unified Government. Stockholders who have not signed the petition will be contacted directly.

New Business to be Discussed:

On January 11, 2022, a semi came through the neighborhood knocking down cable lines. The truck's information was not obtained. The Unified Government has agreed to put a "NO TRUCK" sign at 9th and Quindaro since this is where the trucks are entering the neighborhood. Manager has contacted nine GPS trucking apps telling them to update their GPS systems to show the neighborhood is a no truck residential area. If information is located on the truck that cause the damage it will be reported to the federal motor carrier safety commission and will be subject to a maximum federal penalty of \$11,000 for the company and \$2,750 for the driver. "NO TRUCK" signs will also be installed on 10th Street and on North Allis.

Le Vo, 87 Viewcrest, has requested the Homes take back the part of her yard where all the flowers are on the hill. Floyd Mock had previously lived in the unit and kept expanding the yard by planting flowers. The Homes can clean out the area and add it to the common area for mowing. Frank Moss moves to clean out the flowers and turn the area back into common area for mowing. Seconded by Jerry Demeyer. Carried unanimously.

The board discussed a large truck that has been parked in the community illegally.

Three new security cameras have been installed at the office.

To date for the Kansas Emergency Rental Assistance (KERA) Program has submitted \$19,000 in maintenance fees on behalf of residents. The assistance will continue and The Homes has a few residents whose applications are under review. Residents are encouraged to contact the office if the need assistance through this program.

Comments from Directors and Attorney:

Jerry Demeyer thanked the maintenance staff for all their hard work during recent snow storms.

Comments from Stockholders:

Elaine Hines reported that she had new windows installed recently.

No further business to come before the board the board adjourned into executive session.

Senior Citizens' Utility and Sales Tax Rebate Program

DEADLINE: MARCH 31, 2022

Sales Tax and Utility rebates are offered to eligible citizens who live in Kansas City, Kansas for a portion of their BPU, Gas or AT&T utility bills and/or have paid sales tax.

To qualify for the refund, ALL THREE of the following must apply:

Resident of Kansas City, KS;

65 years of age or older during the entire 2021 calendar year;

Gross household income does not exceed \$25,000.

To apply you'll need the following information:

Name

Last four digits of your social security number

Mailing address

Date of birth

Telephone number

Copy of your 2021 gas, BPU, and phone bills

Proof of 2021 income (social security, pensions, disability, W2 tax reports, interest, etc.), including your spouse's income.

Submit your information today via mail, fax, or in-person at 701 N. 7th Street, Room 323, Kansas City, Kansas 66101. All applications must be received or postmarked by March 31, 2021.

Homestead / Safe Senior Property Tax Refund

DEADLINE: APRIL 15, 2022

Homestead Rebates are offered to eligible citizens who live in Wyandotte County, Kansas for a portion of their property taxes.

If you were a Kansas resident for all of 2021 and owned and occupied a homestead, you are eligible for a refund of \$700 if your total household income is \$36,000 or less, AND you:

Were born before January 1, 1966; OR

Were totally and permanently disabled or blind for the entire year of 2021; OR

Have a dependent child who lived with you the entire year that was born before January 1, 2021 and was under the age of 18 for all of 2021; OR

Are a disabled veteran (50% or more) or the surviving spouse of a disabled veteran who has not remarried, or the surviving spouse of an active duty military personnel who died in the line of duty and not remarried.

As a Kansas resident for all of 2021 who owned AND occupied a homestead, you are eligible for a refund of 75% of your property taxes paid if your total household income including social security is \$20,900 or less, AND you:

Were 65 years or older for all of 2021;

Must not have delinquent property taxes in 2021.

Household income is generally all taxable and non-taxable income received by all members of the household. You can complete a Form K-40H or K-40PT electronically or have our Clerk's Office help you complete the required documentation.

MARCH GUIDELINES FOR LAWN CARE

Prepare Your Equipment for Spring.

When: February through Early March.

After a long winter of freezing temperatures here in Kansas City, and sitting idle in the garage, it's finally time to pull out that old lawn mower and fire up the string trimmer. Be sure not to skip over the basics when preparing your equipment for the season. Sharpening the mowing blades, new spark plugs, and fresh oil and air filters are a good place to start.

Prepare The Lawn for Spring.

When: Early February through Mid March or whenever the snow melts!

Over the past few months, your lawn has become a magnet for leaves, acorns, sticks, and many other forms of debris. Give your lawn a breath of fresh air! Clearing all this leftover debris can make way for any fertilizer and pesticide applications. It also helps prevent any unsightly dead patches in your lawn, which would be the result of leftover matted down leaves and debris.

Loosen Things Up A Little.

When: March or April

Lawn Aeration helps loosen up compacted soil, helping your lawn receive water and nutrients more easily. Aerating your lawn regularly is one of the easiest ways to improve the overall health of your lawn, as well as helping give it that thick, dark green look we all desire.

COVID-19 Booster Shot Eligibility

Wyandotte County – December 22, 2021

COVID-19 booster shots are now available for eligible individuals age 16 and older. This follows authorization by the FDA, as well as recommendations by the CDC and the Kansas Department of Health and Environment (KDHE).

People age 16 and 17 can only receive Pfizer (at this time, Pfizer is the only COVID-19 vaccine authorized for this age group).

People age 18 and older may receive any type of FDA-authorized COVID-19 vaccine for their booster. You are encouraged to get either a Pfizer or Moderna booster. However, Johnson & Johnson (J&J) boosters are still available for individuals who are unable or do not want to receive a Pfizer or Moderna booster.

If you previously got <u>Pfizer</u>, you are eligible for a booster if:	<ul style="list-style-type: none"> ✓ You are age 16 or older, and ✓ You received a 2-dose series of Pfizer or Moderna COVID vaccine, and ✓ You got your second dose at least 6 months ago
If you previously got <u>Moderna</u>, you are eligible for a booster if:	<ul style="list-style-type: none"> ✓ You are age 18 or older, and ✓ You received a 2-dose series of Pfizer or Moderna COVID vaccine, and ✓ You got your second dose at least 6 months ago
If you previously got <u>Johnson & Johnson (J&J)</u>, you are eligible for a booster if:	<ul style="list-style-type: none"> ✓ You are age 18 or older, and ✓ You received a single dose of J&J (Janssen/Johnson & Johnson), and ✓ You got your first dose at least 2 months ago

Please bring your vaccination card to show when you received your previous dose.
