Old Business to be Discussed:

3. How many positive cases in WYCO are among children and young adults under 40?

The smoke alarm inspections have been moved to the fall and will take place in September/October. The fire extinguisher inspections have been completed.

Manager met with the Unified Government Development Committee about adding parking areas in the Roswell and Viewcrest common areas. The UG requires sealed plans from a licensed Kansas designer which is very expensive. Manager is working with Doug Harsh with B&D Contracting who has been speaking with the UG to see if a driveway permit can be accepted in lieu of the sealed plans.

New Business to be Discussed:

Manager is looking into acquiring a parcel of land from the UG's land bank. It is located on the southwest side of North Allis and borders The Homes property line. This would be an ideal location to place an additional parking area. This would alleviate the problem with parking on North Allis and some of Manorcrest.

Security has been increased at the Boat and Trailer storage area with the installation of a keyless numeric keypad lock. Employees and residents have been given codes that will open the lock. Every time a code is used, the office receives a notification. If the lock does not get re-locked within 15 minutes, the office receives a notification. After five attempts at entering the code, the lock will shut down and the office receives a notification.

Manager attended a webinar with the Kansas Emergency Rental Assistance Program (KERA). A few residents that are delinquent do not have computer or internet access. The manager will now have the ability to assist the residents as needed.

In September, cement repairs/replacement will be done in the community. If a resident has a cement issue, they should contact the office.

Unified Government Commission Meeting Update

At a meeting of the Unified Government Board of Commissioners, the Unified Government Public Health Department (UGPHD) leadership as well as Dr. Steve Stites, Chief Medical Officer with the University of Kansas Health System, presented current COVID-19 data to the UG Commission. Some statistics about the current status of COVID-19 in Wyandotte County include:

- The rolling 7-day average of cases per day is up to 77 new cases per day the highest rate since late January 2021, and nine times higher than the average cases per day just two months ago.
- The positivity rate (a 7-day rolling average of positive test percentages) has climbed to 32 percent, as high as it was in mid-January 2021, and more than four times higher than the positivity rate in May 2021.
- Two-thirds of current positive cases in Wyandotte County are among children and young adults under 40 years of age (see chart "Cases in Past 14 Days by Age Group" in Addendum section)
- The vast majority of hospitalized cases of COVID-19 are in people who have not been vaccinated

UGPHD leaders and Dr. Stites said they are especially concerned about the presence of the Delta Variant in Wyandotte County and the metro area because it is much more transmissible than prior types of COVID. Because of low vaccination rates in Wyandotte County, the Delta Variant is causing significant spread of COVID-19 throughout the community. UGPHD leaders noted that Wyandotte County and the Kansas City are experiencing "uncontrolled community spread" (deemed "HIGH" spread by the CDC).

"Given the rapid surge of new COVID-19 cases in Wyandotte County, we had a tremendous sense of urgency to recommend that the Commission take action," said Dr. Allen Greiner, Chief Medical Officer for the Unified Government Public Health Department. "The vast majority of our new cases are among unvaccinated people, and we know that most of these cases are the Delta variant, which spreads more easily than other types of COVID. The best way to protect everyone in our community is for everyone to wear a mask in public places and for those who are eligible, to get vaccinated as soon as possible."

What is Covered by the Mask Order Individuals age five and older must wear masks over the nose and mouth when:

- Inside any public space including businesses and places of worship;
- Obtaining services from the healthcare sector in settings including, but not limited to, a hospital, pharmacy, medical clinic, laboratory, physician or dental office, vaccination site, COVID-19 testing site, veterinary clinic, or blood bank (unless otherwise directed by an employee or healthcare provider);
- Waiting for or riding on public transportation or while in a taxi, private car service, or ride-sharing vehicle; and

All businesses or organizations in Wyandotte County must require all employees, customers, visitors, members, or members of the public to wear a mask or other face covering when:

- Employees are working in any space visited by customers or members of the public, regardless of whether anyone from the public is present at the time; or
- Employees are working in an indoor space; or
- Employees are working in any space where food is prepared or packaged for sale or distribution to others; or
- In any indoor space where members

"We have thousands of children under the age of 12 in Wyandotte County who can't get vaccinated yet," said Juliann Van Liew, Director of the Unified Government Public Health

Department. "Those children will be back in schools within a few weeks. The best way we, as a community, can protect them is to wear masks and for everyone around them who is eligible to get vaccinated. The Delta variant is resulting in more COVID cases among children than previous strains. We need to do everything possible to protect our kids and those who are most vulnerable to infection. Wearing a mask is the simplest and quickest way for us to make a difference in current COVID-19 spread."

Unified Government Public Health Department Issues New Recommendations on COVID-19 Precautions for Social Gatherings

This guidance is issued in response to the recent increase in COVID cases and hospitalizations, as well as the spread of the Delta variant. The UGPHD plans to closely monitor COVID-19 data for Wyandotte County in the coming weeks and reevaluate the gathering guidance in late September of 2021.

Guidance for people who are fully vaccinated

- Safest: Limit gathering size, and wear masks except when both outdoors and socially distanced.
 - o Outdoor gatherings: Choose outdoor gatherings rather than indoor gatherings when possible. Limit to 25 people. If six feet of social distancing cannot be maintained, wear a mask.
 - o Indoor gatherings: Limit to 10 people. Wear a mask and maintain six feet of social distancing.
- Less safe: If you choose to have gatherings larger than the recommended number of people listed above, please continue to wear masks to reduce the risk.
- HIGH RISK: Gathering without masks and without limiting the number of people, particularly if gathering indoors, creates high risk for the spread of COVID-19, especially the Delta variant.

Guidance for people who are not fully vaccinated

- Safest: At this time, people who are not fully vaccinated are strongly advised to avoid gathering with people who do not live in their household.
- Moderate risk: If you do choose to gather, please take precautions to reduce the risk of COVID spread.
 - o Outdoor gatherings: Choose outdoor gatherings rather than indoor gatherings. Limit to 25 people. Maintain social distancing as much as possible, and please wear a mask if six feet of social distancing will be difficult to maintain the whole time.
 - o Indoor gatherings: Avoid indoor gatherings whenever possible. If you do gather indoors, limit it to no more than 10 people, wear a mask at all times, and maintain social distancing.
- HIGH RISK: Gathering without masks and/or with larger numbers of people, particularly if gathering indoors, creates high risk for the spread of COVID-19, especially the Delta variant.

Please note that the guidance above is for personal or social gatherings. It does not apply to healthcare or public health clinics or events where free COVID-19 vaccines or COVID-19 tests will be administered. At this time, the UGPHD urges caution with large events to help reduce the spread of COVID-19 in our community.
